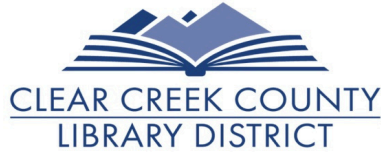

### ***PLEASE READ CAREFULLY BEFORE SIGNING.***

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

The undersigned person (the "Participant") is participating in the following event or program (the "Program") being provided by the Clear Creek County Library District:

The participant acknowledges that participation in the program may involve certain risks, including potential property damage or personal injury or death.

Having been made aware of said risks, Participant voluntarily and knowingly acknowledges and accepts said risks. By signing this agreement, Participant hereby releases, waives, and discharges Clear Creek County Library District and its directors, officers, board members, agents, employees, and affiliates from liability for any and all damages resulting from Participant's participation in the Program, with such potential damages including but not limited to claims for property loss or injury to Participant's person, or even death.

By signing this agreement, Participant hereby agrees to hold harmless, defend, and indemnify Clear Creek County Library District from any and all liability, claims, demands, causes of action, loss, damage, and expenses (including attorney's fees and costs) arising from participation in the program, including claims that are known or unknown, foreseen or unforeseen, future or contingent.

This Release of Liability and Hold Harmless Agreement shall be binding upon Participant, and Participant's legal representatives, heirs, successors, and assigns.

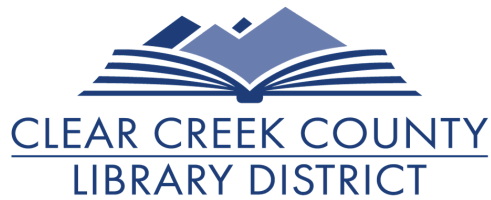
